

BYLAW NO. 03-2016

**A BYLAW OF THE VILLAGE OF PAYNTON TO AMEND BYLAW NO. 03-2010 WHICH PROVIDES FOR
FIXING WATER RATES AND SEWER SERVICE CHARGES**

Council of *Village* of Paynton, in the Province of Saskatchewan, enacts as follows:

1. THAT "Schedule" A" to Bylaw No. 03-2010 as enacted on March 12, 2013 be repealed.
2. THE Schedule attached and marked "A" shall take effect in all respects as Schedule to Bylaw No. 03-2010

THE rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.

BYLAW NO. 03-2016
A BYLAW TO AMEND BYLAW 03-2010

SCHEDULE "A"

Monthly Water Rates:

Basic minimum charge for all water users, pro-rated monthly
\$39.00 per month flat rate billed monthly at \$ 39.00/month

Monthly Sewer Rates:

Basic minimum charge for all sewer users prorated monthly
\$17.00 per month flat rate billed monthly at \$ 17.00/month

Monthly Infrastructure Fee:

The amount of infrastructure fee to be prorated monthly
\$18.00 per month flat rate billed monthly \$ 18.00/month

Notwithstanding properties not within the village taxation system will be charged \$36.00 per month in addition to the above stated rates. If and when these properties become part of the village taxation system, this surcharge will be removed.
